## 3. HAZARDS IDENTIFICATION

### POTENTIAL HEALTH EFFECTS:

This product is a thin water-white liquid with a solvent odor. This product is a flammable liquid and vapor. Vapors may cause flash fire. It can cause eye, skin, respiratory and digestive system irritation. A component is an aspiration hazard. Symptoms of exposure may include central nervous system depression.

**EYE:** This product may cause irritation to the eyes. Symptoms may include stinging, tearing, redness, swelling, and eye damage.

## 4. FIRST AID

## 7. HANDLING & STORAGE

**HANDLING:** Keep liquid and vapor away from heat, sparks and flames. Surfaces that are sufficiently hot may ignite liquid product in the absence of sparks or flame. Extinguish pilot lights, cigarettes and turn off other sources of ignition prior to use and until all vapors are gone.
